**Sweepstakes Rules: "Win a trip and experience the best of Formula at "Las Vegas Grand Prix" with your FirstBank debit Mastercard"**

1. **Duration:** The sweepstakes period (the "Sweepstakes") begins on **July 30, 2024, and ends on October 21, 2024.** There is no need to purchase or pay anything to enter and receive prizes.
2. **Eligibility:** The following are eligible to participate: (i) any natural person (individual); (ii) of legal age (twenty-one (21) years of age or older) as of July 30, 2024; (iii) legal resident of Puerto Rico; (iv) a FirstBank Puerto Rico ("FirstBank") client with at least: (a) a checking deposit account, (b) savings deposit account or (c) combined checking and savings deposit account, and (v) who has a **Mastercard debit card** issued by FirstBank.

The following individuals **are not eligible** to participate in the Sweepstakes:

- Cardholders who have checking, savings, or combined accounts closed.
- Cardholders who have checking, savings, or combined accounts with derogatory status or in overdraft.
- Cardholders who have any other delinquent or past-due accounts with FirstBank, its affiliates and/or subsidiaries as of the date on which the winners are selected by random drawing.
- Officers or employees of FirstBank, its subsidiaries, advertising and public relations agencies, or the immediate family members of such officers and employees. FirstBank may require certification from the winners indicating that they are not included among the people exempted from participating.
- In the event of the participant's death on or before the date of the Sweepstakes, no relatives, heir or estate will be able to claim the prize.

This Sweepstakes does not apply to accounts or products for business customers and corporate clients. This Sweepstakes also does not apply to: (1) Mastercard credit cards, (2) Visa credit cards, and (3) Visa debit cards.

**3. Ways to Participate:**

- a. **Automatic Entries:** Individuals who meet the eligibility requirements set forth in these Rules will automatically receive one (1) entry for every dollar (USD) used on their point-of-sale (POS) purchase, online (internet) purchase, and/or other payments made with their FirstBank Mastercard debit card from July 30, 2024, to October 21, 2024. Payments made through ATH Móvil under "Pay a Business" will not be considered for the sweepstakes.

Transactions will be considered based on the date they are posted to the account associated with the individuals' FirstBank Mastercard debit card used (and not on the date the transaction was made). Only transactions registered during the Sweepstakes period will be considered.

- b. **Entry by Mail:** Individuals who meet the eligibility requirements set forth in these Rules may participate, without purchase or payment, by mailing a 3x5 index card with their first and last name, address, email address, phone number attached to the debit card, and the last four (4) digits of the debit card number to FirstBank Mastercard debit card to Sweepstakes: "**Win a trip and experience the best of to the Formula at "Las Vegas Grand Prix" with your FirstBank debit Mastercard**" Marketing and Corporate Communications Department, PO BOX 9146 San Juan, PR 00908-0146. Shares may not be delivered to any of FirstBank's offices or branches, nor will they be received via fax (telecopier). Only one (1) postal card for one (1) entry will be accepted for the same person for the duration of the Sweepstakes. Entry by mail must be postmarked by the Postal Service between **July 30, 2024, through October 21, 2024**, and must be received by FirstBank at least seven (7) days prior to the date the Sweepstakes will be held.
- c. FirstBank is not responsible for lost, incomplete, illegible, incorrect, late, stolen, unshipped, destroyed, or postage-free entries; or for any error, omission, interruption, defect or delay in transmission in communication; technical or mechanical failures or malfunctions; failures or malfunctions of telephones, telephone lines or telephone systems; failures of electronic equipment, computer hardware or software; or inaccurate entry information, whether due to equipment, of the programming used in the Sweepstakes, due to human processing error, or other cause. FirstBank reserves the right to determine the validity of submitted entries and void any entries on suspicion of tampering with or damaging the administration of this Sweepstakes or entrants violating the Official Rules of this Sweepstakes.

4. **Prizes:** There will be two (2) prizes. Only one (1) prize will be awarded per winner, regardless of the number of entries.

  - b. In the event that the winner is unable to travel on the designated dates, one (1) alternate winner will replace the winner. In such circumstances, the original winner will be forfeited and will not be eligible to receive any prize. This prize is non-transferable, cannot be redeemed for cash, nor can it be substituted or exchanged for other products or services. FirstBank reserves the right to substitute the prize with another of equal or greater value. The winner will be responsible for covering any expenses related to the prize not defined in the Rules, such as: medical expenses, vaccines, Passport, among others. FirstBank reserves the right to substitute the Prize with another of equal or greater value.
5. **Selection of winners by random drawing:** Two (2) winners and two (2) alternate winners will be randomly selected in one (1) single electronic raffle drawing to be held on October 25, 2024. The prize will be awarded to the first two (2) winners to emerge from the draw. On that same date, the alternate winners will be drawn and will take the place of the winners in the event that any of them does not meet all the pre-established requirements in these Rules. We will verify and certify that the winner and his/her alternate meet the eligibility requirements set forth in these Rules. Only one prize per winner, regardless of the number of entries. If a participant is selected more than once as a winner or alternate winner, we will proceed to select another. If the account associated with the randomly selected winning card has more than one signer, the selected winner will be the primary accountholder.
