

Sweepstakes Rules: "Be a First-Class Driver"

1. **Duration:** The period to submit entries to participate in the electronic raffle drawing (the "Sweepstakes") begins on **November 17, 2025** and ends on **January 7, 2026**. No purchase or payment is required to enter and receive prizes.
2. **Eligibility:**
 - i. **Eligible debit card holders:** The following are eligible to participate: (i) any natural person (individual); (ii) that you are of legal age, (being) twenty-one (21) years of age or older as of November 17, 2025; (iii) legal residents of Puerto Rico; (iv) who are also customers of FirstBank Puerto Rico ("FirstBank") with at least: (a) a checking deposit account, (b) savings or (d) combined individual, and (v) who have a **Mastercard debit card** issued by FirstBank.
 - ii. **Eligible Credit Card Holders:** The following are eligible to participate: (i) any natural person (individual); (ii) that you are of legal age (are) twenty-one (21) years of age or older as of November 17, 2025; (iii) legal residents of Puerto Rico; (iv) who are also customers of FirstBank Puerto Rico ("FirstBank") with a Beyond Mastercard individual credit card during the Sweepstakes period.
 - iii. **The following are not eligible to participate in the Sweepstakes:**
 - (a) Cards issued for commercial and/or corporate purposes.
 - (b) Cardholders who are officers or employees of FirstBank and Mastercard, including subsidiaries, advertising and public relations agencies of FirstBank and Mastercard, and relatives up to the third degree of consanguinity of such officers and employees, as well as former employees of FirstBank.
 - (c) Cardholders who have accounts in arrears, overdraft, loss, or otherwise are in breach of the terms and conditions applicable to their relationship with FirstBank, its affiliates and/or subsidiaries as of the date the selection of winners is made by random drawing.
 - (d) Cardholders who have their *FirstBank Mastercard* debit card or *Beyond Mastercard credit card* closed during the Sweepstakes period.
 - (e) Mastercard debit cardholders are not eligible to participate in the Sweepstakes:
 - When your individual checking, savings, or combined accounts are closed, or
 - When your checking, savings, or combined accounts are available to individuals with derogatory or overdraft status.
 - (f) **FirstBank may require certification from winners that they meet eligibility requirements and are not included among those excluded from participating.**
 - iv. **This Sweepstakes does not apply to:**
 - (a) Visa credit cards,
 - (b) Visa debit cards, and
 - (c) to Beyond Business Mastercard credit cards.
3. **Registration and Entries:**
 - i. **Online registration (internet):**
 - (a) **Official Website:** If you are an existing cardholder and meet the eligibility requirements, you may complete and submit the entry form on 1firstbank.com to enroll and participate in the Sweepstakes. The email provided must be the one you have registered in your deposit account or *Tu Banca Digital*, as applicable.
 - (b) **Email:** A cardholder who has an email address provided to FirstBank will receive communications through said email with the details of the ways in which they will accumulate entries. The email will also include an enrollment form. If you are an existing cardholder and meet the eligibility requirements, complete the form with all the requested information, submit it, and agree to the terms and conditions of the Sweepstakes, you will be enrolled. The email provided must be the one you have registered in your deposit account or *Tu Banca Digital*, as applicable.
 - (c) **Facebook:** The cardholder who has an account on the social network Facebook (www.facebook.com), and whose email provided to FirstBank is the same as the one used in said Facebook account, will be exposed to ads that will have the functionality of collecting the

user's information and storing it in the database assigned to Facebook for that ad. If you are an existing cardholder and meet the eligibility requirements, complete the form with all the requested information, submit it, and agree to the terms and conditions of the Sweepstakes, you will be enrolled. The email provided must be the one you have registered in your deposit account or *Tu Banca Digital*, as applicable.

- ii. **Registration by phone:** If you are an existing FirstBank Beyond Mastercard credit card cardholder and meet the eligibility requirements, you can register by phone by calling 1.855.701.2265, indicating to the service agent that you wish to enroll and participate in the Sweepstakes: "Be a First-Class Driver " Upon completion of registration, the existing cardholder will be able to earn entries into the random drawing as provided in Section 3 of these Rules. The service agent will tell you: (1) that you can participate, (2) that you can complete registration during the call, and (3) how you will accumulate entries.
- iii. **Electronic entries:**
 - (a) Cardholders registered online or by phone may, from November 17, 2025 to January 7, 2026, accumulate the following entries:
 - 1. One (1) entry for every \$1 in point-of-sale (POS) purchases. Payments made through ATH Móvil for "Pay a Business" will not be considered as entries for the Sweepstakes.
 - 2. This method of accumulating entries applies to transactions with FirstBank Mastercard debit or credit cards. Transactions will be considered based on the date they are posted to the account associated with the individual's FirstBank Mastercard debit or credit card used (and not on the date the transaction was made). Only transactions will be considered as of the date the existing, eligible cardholder registers online or by phone.
 - (b) **New Beyond Mastercard Credit Card Cardholder:** If you apply for a FirstBank Beyond Mastercard Credit Card for individuals, and subject to approval during the Sweepstakes entry period, and you meet all eligibility requirements set forth in these Rules, you will be automatically enrolled and automatically receive 500 entries upon completion of your first transaction with your FirstBank Beyond Mastercard Credit Card between the dates of November 17, 2025 to January 7, 2026.
 - 1. Thereafter, you will receive one (1) entry for every dollar (\$1.00) in purchases made with your FirstBank Beyond Mastercard Credit Card between the dates of November 17, 2025 through January 7, 2026. This method of accumulating entries applies to transactions with FirstBank's Beyond Mastercard Credit Cards. Transactions will be considered based on the date they are posted to the account associated with the individual's FirstBank Mastercard credit card (and not on the date the transaction was made).
- iv. **Entries by Mail:** An existing cardholder who meets the eligibility requirements set forth in these Rules has the alternative of participating, without having to register and without having to purchase or pay anything, by sending by regular mail a 3x5 index card with their first and last name, address, email (the email provided must be the one they have on file in their deposit account or *Tu Banca Digital*, as applicable), phone number tied to the debit or credit card, and the last four (4) digits of the FirstBank Mastercard debit or credit card number a Sorteo: "Be a First-Class Driver" Department of Marketing and Corporate Communications FirstBank Puerto Rico, PO BOX 9146 San Juan, PR 00908-0146. In the event that such information is not provided or does not match FirstBank's records, FirstBank reserves the right to refuse such participation, as provided in these Rules. All entries submitted will be owned by FirstBank, which may dispose of them at its best discretion. Participations may not be delivered to any of FirstBank's offices or branches or received via fax (telecopier). An eligible cardholder may submit only one (1) entry by mail for the same e-raffle drawing. Mailed participations must be postmarked by the Postal Service between November 17, 2025 and January 7, 2026 and must be received by FirstBank at least three (3) days prior to the date the first random drawing is held, as provided in these Rules.
- v. FirstBank is not responsible for entries that are lost, incomplete, illegible, incorrect, late, stolen, unshipped, destroyed, or postage-free; or for any error, omission, interruption, defect or delay in the transmission of communication; technical or mechanical failures or malfunctions; failures or malfunctions of telephones, telephone lines or telephone systems; failures of electronic equipment, computer hardware or software; or inaccurate information of participation, whether caused by equipment, of the programming used in the Sweepstakes, due to human processing error, or other cause. FirstBank reserves the right to determine the validity of submitted entries and void any entries on suspicion of tampering with or damaging the administration of this Sweepstakes or entrants who violate the Official Rules of this Sweepstakes.

4. Prize:

- i. A total of sixty (60) prizes will be awarded, distributed as follows: thirty (30) prizes will be awarded for debit cardholders, ten (10) prizes will be awarded to the Beyond Ultimate Mastercard cardholders, and twenty (20) prizes will be awarded to the Beyond Platinum and One credit cardholders. Only one (1) prize will be awarded per winner, regardless of the number of entries.
- ii. The prize consists of:

1. For winners who are Beyond Ultimate Mastercard cardholders:

Each winner will receive one (1) ticket and two (2) additional tickets for their guests to participate in a VIP experience with the McLaren Formula 1 Team at Plaza Las Américas, from January 25 to February 1, 2026.

2. For winners who are Debit Mastercard cardholders, Beyond Platinum and Beyond One Mastercard cardholders:

Each winner will receive one (1) ticket and one (1) additional ticket for a guest to participate in a VIP experience with the McLaren Formula 1 Team simulator at Plaza Las Américas, from January 25 to February 1, 2026.

- The VIP Experience has a time limit of 15 minutes.

5. Selection of Winners by Random Drawing: Winners who will receive the prize described in these Rules will be randomly selected at random in three (3) electronic raffle drawings to be held on January 14, 2026. In one of the electronic tombola draws, thirty (30) winners and thirty (30) alternate debit card winners will be selected, in the second electronic tombola draw, ten (10) winners and ten (10) alternate Beyond Ultimate Mastercard credit card winners will be selected in the second electronic tombola draw, while in the third electronic tombola draw twenty (20) winners and twenty (20) alternate Beyond Platinum and Beyond One Mastercard credit card winners will be selected. Each prize will be awarded to each winner according to their information arising from the electronic raffle. An alternate winner will take the place of a winner when the winner does not meet the requirements set forth in these Rules. FirstBank reserves the right to choose additional alternate winners, if necessary. FirstBank also reserves the right to verify and/or require certification from the winner and/or alternate winner (in the event that it substitutes for the winner) that he/she meets the eligibility requirements set forth in these Rules. Only one (1) prize will be awarded per winner, regardless of the number of entries. An entrant may only win one (1) time, therefore, if an entrant is selected more than once as a winner or alternate winner, we will proceed to select another winner. If the account associated with the randomly selected winning card has more than one signatory, the selected winner will be the primary cardholder. 6. Notification: Each winner will be notified in writing by registered mail with return receipt to his/her last known address. In addition, you will be notified by phone call to the number listed on the registration form.

7. All obligations of FirstBank will cease upon delivery of the prize, which will be subject to the signing of a delivery receipt and the corresponding release of liability document or agreement, which will be provided by FirstBank.

9. **Other General Terms and Conditions of Participation:** All information collected by FirstBank will be used only for the purposes set forth in these Rules and in accordance with the policies for the handling of personal information, as instituted by FirstBank. Any fraudulent entry and/or with information that is incomplete, incorrect, false or that in any other way prevents or hinders FirstBank from identifying the participant, whether or not the participant is a winner, will be disqualified and removed from the Sweepstakes without any liability on the part of FirstBank. FirstBank is not responsible for incomplete, incorrect, or unintelligible names, mailing addresses, or email addresses. Any entry that is falsified or appears to have been forged, or shows any other indication that it is not a genuine entry solicitation or that an attempt is being made to damage or undermine the legitimate operation of the Sweepstakes will be disqualified from participating and removed from the Sweepstakes, and the entrant may be referred to the appropriate government authorities for appropriate civil and criminal proceedings. Such determination shall be at the sole discretion of FirstBank and/or its authorized agents. All entries must contain all information required to be valid.
